*All applications must be received by that date in order to be considered. The qualifications and criteria for applying, and the awarded grant amount can be found in the section below.*

The Guam Association of REALTORS® is awarding grants of up to \$1,250.00 to those affected by the devastation of the May 2023 Typhoon Mawar. This grant was made possible by the REALTORS® Relief Foundation, and is available for Guam's community that needs assistance with their mortgage payment, or renters that were displaced from their homes and forced to secure lodging elsewhere.

Those that apply must meet the following qualifications:

- **PRIMARY RESIDENT.**  
You must be a full-time primary resident of Guam. Secondary and vacation homeowners do not qualify to be awarded grant funds. You must also be a United States citizen or legally admitted for residence in the United States.
- **FUNDS ONLY FOR USE FOR MORTGAGE, RENTAL, OR DISPLACEMENT COSTS.**  
The grant funds under this program do not cover loss of income, business, other expenses including second mortgages (home equity lines or loans), clothing, appliances, equipment, vehicle purchase/rental/repair and mileage incurred.
- **FUNDS RELATED TO MORTGAGE, RENTAL, OR DISPLACEMENT COSTS.**  
Any monies awarded through the grant will be related to documentation provided. *(For example, if the applicant's monthly mortgage payment is \$4,000, the amount awarded will not exceed the \$1,250 maximum.)*

The following documents are required for all applicants:

- **CURRENT PHOTO IDENTIFICATION.** Must be a valid Guam Driver's license/Identification card or other governmental documentation evidencing residency.
- **PROOF OF OWNERSHIP/RENTING.** You must provide a current copy of your mortgage statement (or other evidence of ownership) or new lease agreement.
- **PROOF OF DISPLACEMENT.** You must provide a hotel receipt or other related receipts that is dated following the damage incurred to evidence displacement.

One of the following is required to show proof of damage to your primary residence:

- **Photos of Damages.**
- **Insurance Estimate.**
- **Copies of Written Claims, Settlement Proceeds or Claim Status Reports.**
- **Copies of Repair Estimates from Contractors or related professionals.**

All documentation required in the application must be included upon submission of the application in order to be considered and/or avoid delays.

Any and all information provided on the application to the Guam Association of REALTORS® will remain confidential and will be available only to those who need to confirm eligibility for assistance and to those who process the assistance to be provided. It will not be shared with other parties for any other purpose.

In order to provide for a reasonable and equitable distribution of funds, the grant assistance will be provided on a **first come, first serve basis**. Grants are subject to the availability of funds.

**The application period will end on Saturday, September 30th, 2023 by 5 PM** or until the availability of funds are depleted, whichever comes first.

### Application for Disaster Relief Assistance

**Type of Assistance**

Assistance is available to qualified applicants towards one of the following options: 1) Monthly mortgage expense for the primary residence that was damaged by Typhoon Mawar or; 2) Rental expense due to displacement from the primary residence resulting from Typhoon Mawar or; 3) Hotel reimbursement due to displacement from the primary residence resulting from Typhoon Mawar. Relief assistance is limited to a maximum of \$1,250 per household. Deadline for application submission is September 30, 2023. Please note this assistance is for housing relief only; other expenses including second mortgages(home equity lines or loans), clothing, appliances, equipment, vehicle purchase, rental or repair and or mileage are ineligible for reimbursement under this

**Eligibility**

Recipient must be a full-time resident and U.S. citizen or legally admitted for residence in the United States.

**Confidentiality**

All information provided on this form will remain confidential and will be available only to those who need to confirm eligibility for assistance and to those who process the assistance to be provided. This includes providing a copy of this application to the applicant's lender or landlord, if requested. It will not be shared with other parties for any other purpose.

**Disbursement of Funds**

In order to provide for a reasonable and equitable distribution of funds, assistance will be provided on a first come, first serve basis. All grants are contingent upon the availability of funds.
